## 4.0 Workshop

#### 4.1 Public Hearing - School Protection Officer

The Board of Education has the ability to approve the use of a School Protection Officer (SPO) according to State Statute RSMo 160.665. The following is a summary of requirements identified within the statute: Any district within the state may designate one or more teachers (including those with substitute certificates) or administrators as school protection officers. Any person designated by a school district as a school protection officer shall be authorized to carry concealed firearms or a self-defense spray device in any school in the district. A school protection officer has the same authority to detain or use force against any person on school property as provided to any other persons under Chapter 563. Any person detained by a school protection officer shall be turned over to a school administrator or law enforcement as soon as practically possible, but shall not be detained for more than one hour. Any person designated as a SPO must: Complete Certified School Protection Officer Training Program or be P.O.S.T. certified by the Missouri Department of Public Safety. Possess a valid concealed carry endorsement or permit. Annually complete 12 hours of continuing education/training with a local or state Law Enforcement Agency. Please refer to the state statute for a full list of requirements.
